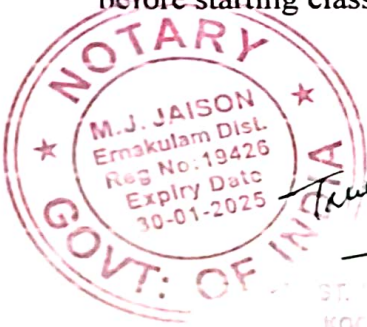
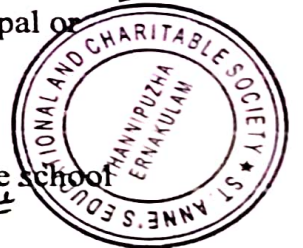
8. That the School will ensure compliance of all statutory requirement like EPF,ESI and Labor Laws etc. with respect to the School and staff of the School.

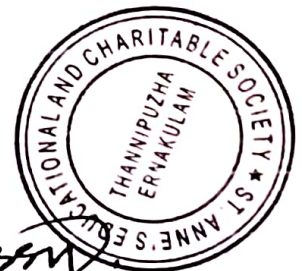
